FINAL MANDATE ON THE NATIONAL GAMBLING AMENDMENT BILL [B27B – 2018]

1. INTRODUCTION

The Chairperson of the Portfolio Committee on Finance, Economic Development & Tourism, Hon M Matika, tabled the Committee's negotiating mandate as adopted by the Portfolio Committee on **Tuesday, 12 March 2019** on the ***National Gambling Amendment Bill [B27B – 2018]***.

2. PROCESS FOLLOWED

- 2.1 The Speaker of the Northern Cape Provincial Legislature has on receipt of the Bill referred the ***National Gambling Amendment Bill [B27B – 2018]***, to the Portfolio Committee on Finance, Economic Development & Tourism on **05 February 2019**.
- 2.2 the Portfolio Committee received a briefing on the Bill from the Northern Cape's Permanent Delegate to the NCOP, Hon W Faber, and the National Department of Trade and Industry on **Tuesday, 05 March 2019**.
- 2.3 The Portfolio Committee resolved to hold public hearings on the referred Bill in all five (5) regions of the Province and also called for written submissions to solicit the views of communities and stakeholders with regard to the ***National Gambling Amendment Bill***.
- 2.4 Five (5) Public Hearings were held on **Thursday, 07 March 2019** in Frances Baard, Pixley Ka Seme, ZF Mgcawu and John Taolo Gaetsewe regions and **Friday, 08 March 2019** in Namakwa Region as per Committee resolution and both written and oral submissions were called for. The stakeholders engaged with the Members of the Provincial Legislature in respect of the Bill.

3. PORTFOLIO COMMITTEE POSITION AT THE NEGOTIATING STAGE


- 3.1 The Portfolio Committee on Finance, Economic Development & Tourism **supports** the Bill.
- 3.2 The House conferred on the Permanent Delegates the authority to participate in negotiations and to raise the concerns expressed.

4. **COMMITTEE POSITION AFTER CONSIDERATION OF NEGOTIATING MANDATE BY THE NCOP SELECT COMMITTEE**

The Portfolio Committee's Negotiating Mandate indicated that the Northern Cape will support the *National Gambling Amendment Bill [B27B – 2018]*.

5. **FINAL VOTING MANDATE**

In terms of Section 65 of the Constitution, the Portfolio Committee on Finance, Economic Development & Tourism recommends that the House confer authority on the Head of its Delegation to the NCOP to vote in support of the *National Gambling Amendment Bill [B27B – 2018]*.
